## **Appendix 1: Guidance for Beneficial Ownership Declaration**

### **A. Entities Limited by Shares**

In an entity limited by shares, the ultimate beneficial owner is a natural person (i.e. individual), who meets one or more of the following criteria:

- i) Has shareholding interest, directly or indirectly, of 25% or more of the shares of the entity;
- ii) Holds, directly or indirectly, 25% or more of the voting shares of the entity<sup>1</sup>;
- iii) Has the right to exercise ultimate effective control, whether formally or informally, over the entity, the directors, or the management of the entity<sup>2</sup>;
- iv) Has the right or power to directly or indirectly appoint or remove a director(s) who holds majority of the voting rights at a director's meeting; or
- v) Is a member of the entity and, under an agreement with another member of the entity, controls alone a majority of the voting rights in the entity.

### **B. Entities without Share Capital**

In an entity without share capital, the ultimate beneficial owner is a natural person (i.e. individual), who meets one or more of the following criteria:

- i) Has the right to exercise ultimate effective control, whether formally or informally, over the entity, the directors, or the management of the entity<sup>2</sup>; or
- ii) Has the right or power to directly or indirectly appoint or remove a director(s);

### **C. Government-owned or State-owned Entities**

In a government-owned or state-owned entity, the ultimate beneficial owner is a natural person (i.e. individual), who has the right to exercise ultimate effective control over the entity, the directors, or the management of the entity<sup>2</sup>.

<b>No.</b>	<b>Description</b>
1	<i>Voting shares are the rights of the holder to vote on resolutions, either at general meetings, or otherwise, on all or most matters.</i>
2	<p><i>An individual has ultimate effective control when the recommendations made by him/her is always followed by members holding a majority of the voting rights in the entity. The recommendation refers to any recommendation or proposal which may influence the decision of the company and can be done formally or informally.</i></p> <p><i>This individual does not need to be a member or director of an entity but is someone that consistently exercises dominant influence or control over the entity, or someone who regularly advises and consults the board of directors.</i></p>
