



Based on the Fund's portfolio returns as at September 30 2025, the Volatility Factor (VF) for this Fund is 14.9 for USD Class (Very High), 15.1 for MYR Hedged Class (Very High), 15.1 for SGO Hedged Class (Very High), and 17.2 for AUD Hedged Class (Very High) (source: Lipper). Very Low includes Funds with VF that are not more than 4.33. Low includes Funds with VF that are above 4.33 but not more than 8.095. Moderate includes Funds with VF that are above 8.095 but not more than 10.695. High includes Funds with VF that are above 10.695 but not more than 14.435. Very High includes Funds with VF that are above 14.435. The VF means there is a possibility for the Fund in generating an upside return or downside return around this VF. The Volatility Class (VC) is assigned by Lipper based on quintile ranks of VF for qualified funds.
